1. Alan Barnard welcomed everyone to the meeting and went through the Health and Safety procedures. Alan then introduced our first Speaker Vicky Perkins who is the Deputy Director of Integrated Services in the Community from Bucks Health Trust. Vicky informed us of current practices in place to support people at home and keeping them healthy and safe. Q&A followed.

AB asked about the eye screening potentially taking place at the Marlow Hub. Vicky confirmed it would be available shortly at that site as currently at Windsor.

KL mentioned the services in Amersham as being particularly useful.

BB asked about the Admiral Nurses support for people living with dementia. Bucks is the only county without one. Can we have it in the next budget and what is the plan? VP replied she would look into it and see what she can find out.

AB mentioned that the Parkinson's Practitioner at the Marlow Hub is an impressive set up. VP keen to put the right services in the right places.

MM mentioned bed blocking, lack of district nurses and Marlow Cottage Hospital being a big loss to the area. Very few people know about the Hub.

LR mentioned we have to look at the whole county not just Marlow.

JK mentioned her concerns about people on their own who have no support and a shortage of volunteers to help.

VP replied that she understands the frustrations and that they are trying to make changes to support the county.

- 2. Main Speaker Trudi Scrivener from Ashridge Home Care. Trudi mentioned her 30yrs in the Care sector was the reason for setting up Ashridge Home Care. She went on to inform us of the benefits of home care; visiting care, respite care and living in care and the affordability of it as an option, rather than having to sell your home to pay for residential Care Homes.

- **4. Notices** –**Michelle Bewley** Michelle mentioned the Talking Café's and updated us on the training available for community connectors and they are looking for people to sign up as volunteers. She informed us of the surgeries in the Bucks area the social prescribers cover and will give PW a list to add to the Hoot.
- **5. Matters arising from last meeting** PW mentioned the notes from the last meeting from David Croisdale Appleby are now on the website.
- **6.** Treasurers Report SS Finances are all looking healthy due to new sources of funding acquired by PW. Just over £17K and some additional advertising income expected too. PW mentioned funding was awarded to fund the Hoot magazine in particular as it had become so popular, and correspondingly more expensive. DW explained the background of how the Hoot has grown and how the funds were needed to keep it going. SS mentioned the reserves policy and explained how it works.

Alan then asked everyone present to introduce themselves to the group and to give any relevant updates.
